The State is empowered to take affirmative action in favour of women under Article 15(3). Article 16 provides for equality of opportunities in matters of public appointments for all citizens.

On the other hand, many States have already made provisions for reserving seats for women in the Local Bodies. **The** 73rd Constitutional Amendment Act provides for reservation of women in Panchayats by reserving not less than one-third seats for them at each tier of the Panchayat. Twenty States namely, Assam, Andhra Pradesh, Bihar, Chhattisgarh, Gujarat, Himachal Pradesh, Jharkhand, Karnataka, Kerala, Madhya Pradesh, Maharashtra, Odisha, Punjab, Rajasthan, Sikkim, Tamil Nadu, Telangana, Tripura, Uttarakhand and West Bengal have made provisions for reservation of fifty per cent of total seats for women in Panchayats at all levels in their respective States.

Political Party Reforms and appointments of women within

In 2023, Parliament of India passed the Constitution (One Hundred and Sixth Amendment) Act, 2023, "Nari Shakti Vandan Adhiniyam", marking a historic milestone in its national journey to foster equitable representation of women in public life at all levels of the federal structure. This landmark legislation rotationally reserves one-third of all seats for women in the Lower House of Parliament, Lok Sabha, and in all State Legislative Assemblies, including Legislative Assembly of National Capital Territory of Delhi, thus institutionalizing representation of women in politics at the highest levels of public decision-making.

V. Political Party Reforms and appointments of women within the Party Structures

The issue of representation of women in political parties is deliberated from time to time. So far, there has not been any provision to fix the number of women in political parties.

3. Status of the CWP in regional constitutions

Women's participation in these elections was notable, with increasing numbers of women candidates contesting across major political parties. In the Karnataka Legislative Assembly elections, out of 224 seats, 34 women candidates contested, and 9 were successfully elected, marking a slightly higher representation than in previous years. In Madhya Pradesh, 28 women contested, with 5 securing seats. Similarly, in Chhattisgarh, 21 women ran for office, and 4 were elected, while in Rajasthan, 32 women stood for election, with 8 winning their respective seats.
